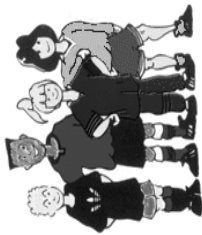

The Austin College Soccer has become synonymous with excellence. Both teams finished with great seasons and good conference standings. In its fourteenth year under coach Paul Burns, the women's program made their mark again in 2010 with over a decade of winning, numerous all-conference players and academic all-conference players. The men's program, under new coach Mark Hudson looks for a strong 2011. Both programs are extremely excited with the prestigious Southern Collegiate Athletic Conference (SCAC) and look forward to competing again this fall.

**KANGAROO SOCCER CAMP for 2011** is for recreational and competitive players, boys and girls from 5 to 16 years old. Our camps are conducted on campus in an enclosed setting; participants have access to the same soccer-only facilities as our varsity players. Special sessions are held for field players and for 2011 we will again include specialist Goalkeeper Training on a morning basis. Campers receive free one camp T-shirt. Technical and tactical training is supplemented with videos and swimming (full day only). Campers enhance their skills while having nonstop FUN.

Coaches are fully licensed, with extensive soccer and teaching backgrounds. Counselors include men's and women's varsity players, many of whom have coaching licenses.
