Due to inconsistencies in our Procedures and their Violation of what is currently under NTSSA's language about AllStars, until we receive ruling from NTSSA, the All Star discussion is On Hold.

I have provided an initial inquiry into this with respective resources at NTSSA, and we are working schedules over the next few days to convene – email specifics sent to Michael, Bradley, Ryan and Ben.

Buzz/Lens

- For those that recall or were here, after receiving feedback from TSA members, we opted to vote for multiple photo vendors to service Sherman/Denison for proximity / ease of our membership for our current soccer year.
- We received 4 proposals as well and unanimously voted on two vendors.
- True to our annual continuation of same vendors for Uniforms/Awards/Photographic services, we continued in the Spring.
- Filling in for a resignation on our Board, Ben had a good conversation with Buzz and worked through logistics.
- But on 3/4 Buzz contacted Ben in email and stated that Buzz would not service TSA and cited reasonings such as we were in Violation of an Exclusive deal between us / them, and our own Bylaws – citing a handshake with a Dir of Association of Development 2 directors ago.
- We placed verbiage on the website immediately to inform TSA this occurred and the timing: "Buzz decided Monday 3/4 not to provide services to TSA this season. We are working with other vendors on sort notice to see if they can help, for now please reserve with Celebrate".
- In addition, Buzz sent cancellations to their customers, our membership stating that we violated a exclusive contract and that we violated our own Bylaws.
- 3/7 I reached out to my legal counsel who informed we that we are covered, and noted that if Buzz continued we might need to seek damages due to defamation due to incorrectly slandering.
- 3/7 I reached out to NTSSA and make sure that our Procedures cover our situation, which was noted, "if your board determined that one vendor could not properly service the membership of TSA and your minutes reflect that. Your bylaws are clear that proposals are to be received annually. In addition, the only thing our Bylaws notes about vendors is: "2.2.1.1 states that you will select vendors to support the association and 2.3.7 states that the Ops Coordinator will obtain proposals every July

for uniform/award and photos." Therefore we were not in violation of bylaws or some sort of exclusive deal with Buzz.

- 3/11 Buzz reached out directly to me telling me to remove the slander intended rebuke on the Texoma Soccer website, and threatened to take it further if needed. Your decisions can be well broadcast. Which at this point I appreciated the email but asked what he was referring too – he mentioned the language on the website where we noted prior.
- 3/11 I provided a response to Buzz noting that:
 - I was out of town, but it would be removed by the end of the day
 - Thanked them for the support and service they have provided over the years.
 - Outlined our process for 3 proposals, and provided context that occurred prior to last Fall.
 - I notated that if there was some exclusive agreement to please send it over, but to our knowledge this didn't exist, and informed him again our 3 proposal requirements.
 - I notated that we were not in violation of our ByLaws, but also noted that under Section 12 of our Procedures, we have reserve the right to add vendors (pp)
 - I also notated that any previous agreement of inference of exclusivity was promised in correctly, apologizing for the confusion.
 - Lastly I humbly apologized for the confusion and our lack of clear communication that might have occurred, noting that I was hopeful they would consider working with us in the future.



Michael to provide a financial update



Due to lack of registration we had to reschedule our Grassroots license coaching by NTSSA hosted by TSA.

The updates are:

- 4v4 DHS Indoor
 - Virtual Meeting: May 23rd 5:30 pm 7:30 pm
 - In-Person: May 25th 10:00 am 12:00 pm
- 9v9 DHS Indoor
 - Virtual Meeting: May 23rd 7:30 pm 9:30 pm
 - In-Person: May 25th 12:30 pm 2:30 pm



- From AGM / Direction of NTSSA from Michaels conversations,
 - In our savings, we should have no less than 6 months of our expenditures/costs in our savings account
 - After reviewing with Michael, this average is \$200k
 - In addition, based off Seth's discussions with our contacts in the insurance team, and experience with malpractice, etc, we need to ensure we have 3x deductible for the highest insurance claim we are responsible for.
 - \$25k = \$75k
 - Total we should have in CD/Savings = \$275k to cover us.
 - We are not there yet, and will continue to transfer overages to the CD.
- May 2023 "fundraising for future field projects". Indoor and logistics was tabled refreshed to Future growth with emphasis on fields first.
- Development was tasked with Fundraiser ideas.
- Indoor Eligibility is currently under review with NTSSA due to their ByLaws regarding Indoor Facilities / For Profit status. All indoor activities are on hold until all questions / direction received by NTSSA and TSA agrees on a process and logistics.
- An indoor facility seems to be considered a "for profit" entity –
- Checking with NTSSA on the process, roadblocks, or issues with implementing an indoor program for money.
- NTSSA outlines separate board members for indoor facility businesses as it is for profit.

• Indoor facilities may only use registered NTSSA indoor referees

I wanted to get your ideas for Fundraising.

You don't have to give it today, but over the next week, I would like to hear your feedback and let's set a plan in motion by AGM.

Her kids are very busy and she can't make meetings, or be as involved as she'd like. And she doesn't want to let me (assuming all of us) down.


She committed to finding a replacement as area director.


Board approved to add another Photo Vendor to replace Buzz – who stepped away from TSA last minute.
