- Financial Report from Michael and all Google suits offers.
 - FINANCIAL REPORT Main account \$121,065.50; Spending account \$142.40; Club 34753.52; still have \$100,000 CD.
 - Google suites business plus, google calendar all integrated. Send out email reminder via calendar instead of GroupMe. Set next meetings on google calendar and setup virtual session to login with TSA google account, google meets. No time limits and records as well as saves on google drive. Start meeting from calendar. Template available for minutes, automatically saves to google drive. Google chat also available. Search entire calendar or chat in google chat/calendar; use shared drive for everyone to use, edit and access and to be all in one place. Can save on google drive/cloud, etc. for everyone to access to it. Have one set up for club and one for TSA, Kevin set up as admin. TSA as view only for club.
- Jason would like to speak on refs.
 - New referee clinic 02/12 Sunday afternoon, received inquiries, can't see who has signed up for online portion as that is part of North Texas Soccer. On 02/19 Jason would like to do refresher training for existing referees for rules updates, etc. The session can include coaches potential scrimmage of u9-u12 for real time game scenarios. Incentive for showing up free referee shirt, signup sheet with size to have by first game. 24 referees currently available/certified.
 - Seth suggests a sign-up session where potential referees bring their laptops and sign up online together – group event. If everyone recertifies, then we will have 50 referees in total. Update link on website to advise there are other dates available for training. Potential shift differential in the future. Need a vote for purchase of referee shirt for incentive.
- o Jordan on sponsors
 - Currently offering 5 different levels of sponsorship, suggesting to change it to 3 to support referee/coach/player of the week. In addition to sponsorship, have coaches speak to players strengths for the nominated player.
 - Confirmed sponsorship with Elite Athletics has been severed due to potential conflict of interest.

 - U7/U8 max roster 8 (4v4)
 - U9/U10 not allowed to punt
 - Currently trying to file an exception; will verify at next meeting to determine if it is approved or needs to be updated.
 - Must be updated yearly.
 - Potentially make 3 fields instead of 2 on field 4/5 at THF for fall 2023. Ask City of Denison if this is possible.
- Review old/updated bylaws and procedures and vote on any changes- this includes changes to the club.
 - Removing Texoma Soccer Club Director as a member of the board moved as an appointed position. Lauren motions to make change – Thomas and Jay second the motion – approved by unanimous vote.
 - Updated Director of Association Development to reflect social medial responsibilities and obtaining sponsorships – Lauren motion to edit job descriptions, Jay seconds the motion – approved by unanimous vote.
 - Secretary has 10 (ten) days instead of 30 (thirty) to provide requested documents Lauren motions to make the change – Miranda seconds, Thomas abstains – approved by majority 2/3 vote.
 - Updates to Club Director and establish a club committee Lauren motions to make change, Thomas seconds the motion, approved by unanimous vote.
 - TSA Board to assist the operations coordinator Lauren motions to approve, Seth seconds the motion, motion approved by unanimous vote.
