Agenda/Discussion:

- Approve last months meeting minutes
 - o Seth mentioned amendment to previous meeting minutes due to change in registration fees.
 - o Motion by Seth, seconded by Micheal, Approval Unanimous
- Financial Report Michael presented report. (see email). Club budget due by July.
 - Action item to put on the future agenda for the movement of the cd. Research needed on nonprofit status and options to increase the interest.
 - Action item to put a future expenses on list financial report. Discussion took place regarding anticipated fees from now to July. Gotsport is continuous since registration is open. Goal purchasing may be needed also. "budget vs actual report" needed for next meeting
- o Adult Commissioner Voting Rights

- o Adult League Field Marshall
 - Bradley requested adult league has a field marshal moving forward. Budget was brought up and confirmed. No field marshal was needed in the past, AC was onsite. Questioned why we didn't have one initially in the budget, statement made – number of players enrolling was unknown and had support from the city officials at THF.  - print off new field sizes, team playing rules changes. Discussions took place regarding location changes. What are the correct field dimensions going to be? Are they going to be adjusted? What is moving to pecan and staying? How many of each field?
 - Motion to table this discussion on field information until after AGM Motioned by Ryan, Seconded by Jay, All approve
- o Referee Trailer
 - City approved a ref trailer for referees to be out of hot/cold weather. Jason takes the floor massively against it. Jay expressed concern to put male/females inside the trailer. Bradley's company would be able to cover cost.

- Motion to deny ref trailer by Dustin seconded by Jay all in favor of not having ref trailer all hands raised in room.
- Indoor Facility Fundraising
 - Jason requested discussion open to the floor. Seth set the grounds for motion. Do we want to start a very generic fundraising for future improvement. Thomas agreed, should have nice facilities available. Jason mentioned two presidents ago there was a start to search for indoor options. Nothing was in the price range and nobody would commit to fundraising. Questions posed regarding where the facility would be.
 - Miranda mentioned who would be the trustee for the land/structure. What is the history of each city and their relationships. Sherman use to let everyone play for free. Fairview then started charging \$20 per player. Players were relocated to THF and then we had players at both locations. Conversation was stemmed from current relationship being "rocky" with Sherman and great with Denison. Motion to amend "fundraising for future field projects". Find out how does the trustee work.
 - Motion to start fundraising and table the logistics for another time. Miranda makes the motion to start fundraising for future growth, Seth second, all approve. Amend motion by Seth to start immediately. Ryan second. All agreement no opposed.

 - Motion by Seth, second by Miranda. Final decision not made.

 - Second by Seth approved by all.
